

### **3Q25 SHAREHOLDER LETTER**

## **Cromwell Greenspring Mid Cap Fund**

Dear Fellow Shareholders:

Reflecting the overall strength within the equity markets, the Cromwell Greenspring Mid Cap Fund (the "Fund") returned 4.22% during the third quarter, bringing the Fund's year-to-date total return to 7.94%.

Our goal is to position the Fund to participate in strong markets while also seeking to preserve capital when conditions become volatile, aiming to produce attractive long-term, risk-adjusted returns. Although the Fund underperformed the Russell Midcap Index this quarter, over the five years ended September 30, 2025, its equity investments achieved an annualized total return of 16.47%—exceeding the Index's 12.66%—while exposing investors to 10% lower volatility (as measured by standard deviation).

The quarter started on a positive note as passage of the "One Big Beautiful Bill Act" provided meaningful policy clarity, shifting investor focus to the potential growth benefits of favorable tax changes, including lower rates, and a

less restrictive regulatory environment. Tariff developments also trended positively throughout the quarter, with deadline extensions, framework agreements with several major trading partners, and ongoing negotiations with others easing concerns about worst-case outcomes.

Optimism was further fueled by strong corporate earnings announced during the quarter. Many companies managed through tariff uncertainties better than expected, adjusting operations and pricing to offset higher costs without significantly impairing demand or profitability. Compared to fairly muted investor expectations, the solid earnings results and constructive management commentary boosted investor sentiment and stock prices.

Throughout the quarter, market participants remained intently focused on macroeconomic indicators—especially inflation and employment. Despite fears that tariffs would cause significantly higher prices, the data proved otherwise,

Prior to the close of business on 8/11/23, the Fund was managed as a mixed-asset fund investing in both equities and fixed income securities and had income as a secondary investment objective of obtaining income. From 12/31/20 to 8/11/23, the Fund held between 11% and 20% in fixed income securities; from 5/31/14 to 12/31/20, the Fund held between 22% and 48% in fixed income securities.

indicating only a modest uptick in overall prices. However, confidence in the resilience of the job market was dented after a series of soft employment reports. This combination of lower-than-expected inflation and slowing employment led the Federal Reserve to cut the federal funds rate by 25 basis points at its September meeting.

Companies associated with the excitement and future potential of artificial intelligence ("AI") enjoyed strong share price performance during the quarter. This enthusiasm has pushed valuations of Al-related companies higher, creating heightened investment concentration risk within the so-called "broad-based" S&P 500, where the top seven companies now make up about 35% of the Index's market value.

Several of the Fund's holdings across different industries have benefited from robust spending associated with the expansion of AI infrastructure and applications. Importantly, beyond exposure to this secular growth trend, we believe these holdings also exhibit the attractive financial qualities we seek—strong balance sheets, robust free cash flow generation, and reasonable valuations.

As shown below, the three largest contributors to the Fund's third quarter performance have all benefited from the Al-driven surge in infrastructure spending. Each ranked among the Fund's largest holdings and outperformed the Russell Midcap Index.

- **EMCOR Group**, a leading mechanical and electrical contractor, continues to see elevated demand for highly specialized work to support the construction of data centers and other advanced manufacturing facilities.
- MYR Group, which provides electrical construction services to the utility industry, is benefiting from increased spending on transmission and distribution networks needed to meet the growing electricity demands of Al data centers.
- Nextracker Inc., one of the world's largest providers of solar trackers used to position utility-scale solar arrays to maximize power output,

is also benefiting from growing electricity demand, as new solar power generation offers a fast and cost-effective source of incremental power supply. The Company has also deftly utilized its strong balance sheet and free cash flow to acquire complementary businesses that should benefit from Nextracker's capital resources and sales force.

We continue to maintain a diversified portfolio of companies outside the direct AI ecosystem—well-capitalized businesses with strong free cash flow, capable management teams, and what we consider attractive valuations. These companies are working to create substantial value through profitable growth and disciplined capital allocation. We are also encouraged to see several portfolio companies pursuing strategic initiatives—such as leadership changes, acquisitions, and spin-offs—that we believe can unlock long-term shareholder value.

Alight, Inc. is one such example. Although the stock was the largest detractor from performance during the quarter, we added to our position after



the stock declined following disappointing second quarter results. Alight is a leading administrator of employee benefits, providing essential software and services that help large commercial clients offer attractive health and retirement programs to their employees. Over the last eighteen months, Alight has attracted activist investors, sold a slower-growing division to strengthen its balance sheet, and appointed a seasoned CEO. Alight is now intently focused on leveraging its new, cloudbased software platform and providing a high level of customer service. Although recent results have shown progress, new sales are taking longer than expected to materialize. We viewed the share price weakness, combined with our confidence in Alight's strategic direction, as an attractive opportunity to purchase additional shares at, what we believe is, a very attractive price relative to Alight's free cash flow generation, dividend yield, and long-term growth potential.

While equity markets—and the Fund—ended the quarter at or near record highs, we believe that attractive investment opportunities remain, as the Russell Midcap Index continues to trade at multidecade lows relative to the S&P 500 on expected earnings and cash flow. We remain committed to our disciplined investment approach aimed at delivering shareholders attractive long-term, riskadjusted returns. We appreciate your investment in the Cromwell Greenspring Mid Cap Fund and will provide a further update in early 2026.
